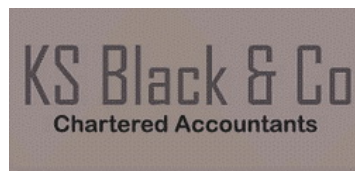
## Generic Universal Design Position Statement
